Responding to your request for "comments on whether or not to rescind the 80 dB noise standard regulation for heavy and medium trucks".

Grove Manufacturing Company respectfully takes this opportunity to request rescission of the 80 decibel (dB) noise emission regulation for heavy and medium trucks. Grove is a "related manufacturing industry" which designs and manufactures truck driven and carrier mounted hydraulic cranes.

- Our request for rescission of this regulation is based on the following considerations:
 - Type of Product Minimum highway travel time, i.e., frequency and distance to work sites. Work site environment (normally construction related activity) with craning work functions performed.
 - Regulations which upon later evaluation involve costs which bear no reasonable relationship to the actual benefits derived from specific industry related products.
 - Finally, the costs to comply with the lower 80 dB noise level may impose significant and perhaps unwarranted economic burdens upon our industry.
