# 6. Reports

- a.) report from Technical Council (Mike Stinson)
  - No-shows in sessions an ongoing problem. Session chairs need to be sure that the session forms contain note of missing authors and are returned to ASA

- ASA members can get involved in a variety of ASA administrative committees, internal and external. Contact chair of these committees or chair of TC-Noise if interested
- An Interdisciplinary Specialty Group is proposed to identify technical areas that could be part of ASA not defined by a single TC. If interested, contact chair of TC-Noise
- There is a proposal to form a committee composed of people who are active in another Society, to identify topics of interest, exchange information, etc. Anyone interested in volunteering should contact the chair of TC- Noise
- b.) JASA Associate Editors for Noise (Keith Attenborough, Ken Cunefare, Vladimir Ostashev, Brigitte Schulte-Fortkamp)

  New Associate Editors getting started, going well. The References to Contemporary Papers in Acoustics has been a fixture of JASA for decades but is now expensive and getting unnecessary given the capabilities of search engines such as Google Scholar. Only a couple people present still use RCPA.
- c.) JASA Express Letters (formerly ARLO) Associate Editor for Noise (Mike Stinson)

The Editor of JASA Express Letters, Keith Wilson, explained the purpose and advantages of this part of JASA, and handed out fliers. Only one person in the audience had used ARLO and he wasn't planning to use it again because of its low impact factor – however, with JASA Express Letters becoming part of JASA, the impact factor has risen to the respectable level of JASA.

Several dossiers under consideration. Have a look in the membership directory to ensure that Noise people who should be Fellows of the ASA have been properly recognized

f.) ASACOS (Rich Peppin)

Steve Brown reports that Standards is supporting itself, looking to license group downloads of standards as a member benefit. In an e-mail report provided by Rich Peppin before meeting that the chair of TC-Noise wasn't able to open until afterward, have following points: (1) a new stand alone draft on sound power in reverb rooms for HVAC units; a contentious discussion led to a draft to be balloted before end of summer, (2) reps to ASACOS: nomination committee will request from TCN Chair a rep on ASACOS before fall meeting, (3) there will be no S Committee meetings in Paris, (4) P. Schomer discussed site license for ASA developed

standards, i.e., a company of 5000 employees or a group of 100,000 members can buy one or more standards for each member for some amount of money, (5) next ASACOS: Wednesday in Honolulu, (6) next S2 meeting will not be with ASA but with Vibration Institute in San Antonio 18-22 June 2007, (7) they want to have a session on standards in Paris.

David Lubman notes that ASA PoPP issued a statement on the use of amplication in classrooms. A copy of this statement will be sent out with these Minutes. Ongoing discussion about noise and marine mammals.

  The Director of the Modular Building Institute has been interacting with

  ASA to resolve differences of opinion. David and Lou have given them a

  presentation at their annual meeting. The Collaborative for High

  Performance Schools (CHPS) has been convinced of the need for good
  acoustics in schools, they are promoting ANSI S.12.60, and their actions
  are being held as an example for schools elsewhere in the US
- j.) Joint AA/Noise subcommittee for speech privacy in health care buildings (Greg Tocci)

  Successful sessions this week. The joint committee is working on an ANSI standard for speech privacy and has been approached to develop quidelines for AIA and AHA.
