  - Lou Sutherland has been impressed by the sound reinforcement systems. They were consistently high quality
  - Some voiced concern that there are too many conferences on Noise, worldwide.
- 2 Lou Sutherland's funding for Classroom Acoustics Booklet should be rerequested. Will not spend it this year.

  about 4 manuscripts per year. These are generally good quality letters
  and my acceptance rate has been quite high."
- b) Young Presenters (Joe Posey)

"50 contributions (presentations or posters) were judged in the Young Presenter competition sponsored by the Noise Technical Committee at the 155th Meeting of the Acoustical Society of America in Paris, France, 30 June – 4 July 2008. This included all of the applicants except for 3 who failed to present. Three reviewers evaluated most of the presentations.

Three of the presenters were recommended for an award by all three reviewers, three presenters who were recommended for awards by two of the three reviewers with very high marks, one undergraduate presented a poster which received very high marks for quality from all three judges.
